- In the Re-use Loop, our experts manage item returns, warehouse, and transportation services for reusable material streams.

RLG's Canada operations began in 2021. We are based in Ontario and have two locations: an office in downtown Toronto and an auditing facility in Brampton.

Our operations commenced due to our role as the Ontario Blue Box program operator. We have a team of over 60 people and provide auditing services, segregating the recyclable material into 80+ categories and reporting back to the producers via the PROs. This assists producers in better understanding how consumers dispose of their products and where they may need to focus promotion and education efforts moving forward.

Additionally, within Canada, we are an electronics and batteries PRO in Ontario and service producers by providing data management expertise and EPR compliance services.
